2024 Environmental Justice Advocacy Priorities

Support dedicated funding for New Jersey Transit.

Governor Murphy's proposed budget includes the first-ever dedicated source of funding for NJ Transit via a 2.5 percent corporate transit fee on corporations with more than \$10million in annual profit. We support this important step while acknowledging that it alone is insufficient to address the dire need. Moreover, we are concerned by the proposed double digit fare hikes that will disproportionately impact riders who are low wage workers. A robust and adequately funded transit system is critical for addressing climate change but must be implemented in an equitable wat that ensures affordable access to all.

Support the NJ Clean Energy Act of 2024 (A1480/S237).

This bill would establish 100 percent clean electricity standards for New Jersey. We advocate for genuine "clean" energy standards and oppose false climate solutions such as trash incinerators (which disproportionately impact marginalized communities) and technologies such as carbon capture, renewable natural gas, and hydrogen (which do not exist).

Prioritize "Green Job" development in underrepresented populations and communities

New Jersey's clean energy transition is expected to generate about 11,000 jobs annually. As Dr. Elizabeth Stanton, Director and Senior Economist of Applied Economic Clinic has said, the state must "require public policy to reduce employment barriers including bias against women and people of color, lack of childcare or transportation, and hiring practices that benefit friends and relatives of people already working in the field." As faith leaders committed to Environmental Justice, we advocate for policies that ensure such jobs target those communities that have borne a disproportionate burden from the impact of climate change.

Support the NJ Green Amendment (ACR119/SCR43). This proposed constitutional amendment would make the State of New Jersey trustee of public natural resources and guarantee to the people the right to clean air, clean water, and a healthy environment.
